To promote safety and comfort, you should act appropriately at all times when in Youth Center facilities or participating in a Youth Center program. You agree to abide by all policies and procedures of the Youth Center and understand that failure to act in accordance with these policies and procedures may in the sole discretion of the Youth Center result in expulsion from Youth Center facilities and revocation of your membership.

("Youth Center") program, without respect to location, along with the payment of the fee, if any, for participation in the program, the undersigned Participant (and, in the case of a minor Participant, the undersigned Parent/Guardian of the undersigned Participant), for himself or herself and his or her personal representatives, heirs, and next of kin, hereby acknowledges, represents, and agrees:

- Assumption of Risk.** He or she has, or immediately upon entering or participating or allowing the Participant to participate will, inspect and carefully consider any premises, facilities and/or equipment in connection with the program. He or she finds and accepts the premises, facilities and/or equipment as safe and reasonably suited for the purpose of the program. By entering or participating or allowing the Participant to participate in the program, there is risk of injury. I knowingly and freely assume all risks, both known and unknown, even if arising from the negligence of the Youth Center and/or its directors, officers, agents, representatives, volunteers, employees, other participants, sponsors, advertisers, and other persons ("Releasees"), and assume full responsibility for my participation and, in the case of a Parent/Guardian, for the participation of the Participant.
- Program Fees.** The fee paid, if any, is for allowance to participate in the Youth Center program and is not in any way for the use of any facilities.
- Release, Indemnification, and Hold Harmless:** I, for myself (and, in the case of a Parent/Guardian, for the undersigned Participant) and on behalf of any heirs, assigns, personal representatives and next of kin, hereby release, indemnify, and hold harmless all of the Releasees from any and all liabilities incident to my participation or, in the case of of a Parent/Guardian, the participation of the Participant in the program, even if arising from the negligence of any one or more of the Releasees, to the fullest extent permitted by law. I grant permission for the Youth Center and its officers, agents, representatives, volunteers, and/or employees to act on my behalf in case of medical emergency, consent to treatment by emergency personnel, and am responsible for all medical expenses.
